These 31 members made very welcome donations to AAUW from August 20, 2015 to July 5, 2017. It was a generous total of \$7,986. In addition, the San Antonio Branch contributed \$2,000 in 2016, and \$2,500 in 2017 to the AAUW Fund and \$80 in memorial donations for eight deceased members. This added \$4,580 to the individual member donations. Thus, this branch donated a total of \$12,566 in a 23 month period. The majority of our donations went to the AAUW Fund. This selection allows National to focus their dollars on programs that need immediate attention.



Kirsta Leeburg Melton is the Deputy Criminal Chief of the Human Trafficking and Transnational/Organized Crime Section of the Office of the Texas Attorney General. From 2000-2014 she prosecuted in the Family Justice Unit of the Bexar County District Attorney's Office, combating human trafficking, physical and sexual abuse of children and family violence, and in 2012 helped establish and lead the Bexar County DA's Human Trafficking Unit. Melton also chaired the Alamo Area Coalition against Trafficking, a regional multi-disciplinary group of law enforcement, non-profits, government agencies, business people, and academics assembled to coordinate the fight against human trafficking. She has trained more than 10,000 people across the state on human trafficking and has testified on multiple occasions before the Texas legislature on trafficking related issues. Melton graduated from Cornell University in 1993 and received her JD and Masters in Public Affairs from the University of Texas in 1998. In addition to prosecuting, Melton is one of the founding members of Truckers against Trafficking, a nationwide campaign dedicated to educating, equipping, empowering and mobilizing the trucking industry in the fight against human trafficking.

Can We Talk is a coalition of over sixty-five women's organizations in San Antonio, Texas. Can We Talk events are scheduled each year in March, to commemorate Women's History Month, and on or near August 26, to commemorate Women's Equality Day and Texas Women's Independence Day. Can We Talk events are coordinated by a steering committee made up of representatives from member organizations.
