# How to Become an Effective AAUW Activist

To be an activist for issues you care about, you don't have to march anywhere. You can simply sit at your computer, open your tablet or smart phone, and vote. At this AAUW site (www.aauw.org/what-we-do/public-policy/two-minute-activist/) you will find many options for making your voice heard.

If you want to be an activist for fair pay for women, education, Title IX, and others, look to this quick solution. You can use the reply AAUW has provided for an issue, or you can type in your own words explaining why you are for or against any specific issue.

Now is the time to focus on the Title IX changes recently called for by Secretary of Education, Betsy DeVos. She wants to reverse several items in Title IX that will negatively impact victims of sexual assault. To learn more about AAUW's concerns about such changes to Title IX check out the article below. There is an urgency because a 60 day window of time began November 29 to allow citizens to post opinions about the changes. Now is the time to take this action.

Taking Action for Title IX

"The Department of Education has announced a plan to make sweeping changes to Title IX's regulations, which would have significant implications for students' civil rights. Specifically, the proposed rule would weaken Title IX's protections by narrowing the definition of sexual harassment to allow schools to exclude much of the abuse students

experience, limiting when schools will respond, and putting in place processes that make it harder for students to come forward when they experience sexual harassment or assault. Simply put, these changes will make schools less safe for students.

Over the next 60 days, we have an opportunity to weigh in with the Department of Education on their proposed changes. With students' safety under threat, we all must make our voices heard. Add your name below to join with AAUW in urging the Department of Education to keep Title IX strong.

#### **Effective Activist Continued**

Education's proposed changes would weaken students' Title IX protections by narrowing the definition of sexual harassment to potentially exclude much of the abuse students experience and limiting when schools will respond to reports of sexual harassment and violence. In addition, the rule would put in place school processes that make it harder for students to come forward and receive the support they need when they experience sexual harassment or These changes assault. would ultimately make our schools less safe.

As Secretary of Education, you have the power to address this critical civil rights issue and help make schools safer and more equitable for all students. I join with the American Association of University Women (AAUW) in urging you to withdraw the Notice of Proposed Rulemaking on Title IX and to work to ensure schools protect students from sex discrimination by fully enforcing, not rolling back, Title IX's protections."

# **Every Little Bit Counts**

In the last newsletter I addressed how the branch uses income to support our activities and scholarships, and now I would like to focus on a broader commitment to AAUW's national programs.

The AAUW San Antonio Branch bylaws state our purpose is to advance gender equity for women and girls through research, education, and advocacy. Our membership dues provide some support for local and national programs to fulfill this purpose. From each member's dues payment, \$59 is paid to National, \$13 to AAUW Texas, and \$16 to the branch. One topic of discussion for the board of directors has been our monetary support of National's programs. While we are often focused on local fundraisers and graduate scholarships from our endowment investments, we should consider supporting AAUW initiatives at local, state, national, and global levels to empower women and girls to break through educational and economic barriers.

In 2017, the AAUW San Antonio Branch made a commitment to support AAUW's national programs with most need. On March 31, 2017, we entered into a memorandum of understanding with AAUW to establish an honorary fund of \$5000 to be paid by May 1, 2018. The branch made two payments of \$2500 to complete this agreement, and sent the final payment to AAUW in June. As the board considers further contributions, which national programs would you as a member choose to support? Here are some of the AAUW funds for your review:

The Eleanor Roosevelt Fund For research to provide analysis, data, and accurate information.


The Leadership Programs Fund For developing women's potential to lead in their schools (e.g. National Conference for College Women Student Leaders, Campus Action Projects, Elect Her).

The AAUW Action Fund
For advancing equity through activism and voter mobilization.

The Legal Advocacy Fund
For protection of legal rights of those facing discrimination.

The Educational Opportunities Fund For learning opportunities giving women a chance for lifetime success (e.g. Fellows Alumnae Initiative, Fellowships and Grants, Tech Trek STEM workshops).

The Public Policy Fund
For public policies and laws fair to
women (e.g. Government Relations,
Civic Engagement, Field Organizing).
